

George Soros, along with Stanley Druckenmiller, were responsible for "Black Wednesday" in

England, by "breaking" the British Pound.

Stanley Druckenmiller worked for Soros Fund Management and Soro's Quantum Fund. Druckenmiller also works with Peter Thiel's Palantir.

Peter Thiel was an early investor in Ripple, but was called "OpenCoin" when he invested in the early days of the company.

Both George Soros and Peter Thiel invest or work for many companies with "Open" in the name, including: Open Israel University, OpenDoor, OpenCoin (Ripple), OpenAI, OpenSea, Open Society, OpenCog, Open Whispers System (Signal), Open Garden, and many more.

Stanley Druckenmiller also funds: Relationship Science Oscar Health



Chain Merges with Lightyear, Goes All-In on Stellar

Combined company, to be called Interstellar, will help organizations build on the Stellar Network; Stellar Development Foundation to remain independent

SAN FRANCISCO, September 10, 2018 — Chain, Inc. ("Chain") today announced it has been acquired by Lightyear Corporation ("Lightyear"), a Stellarfocused commercial entity formed last year with the support of the Stellar Development Foundation. The Chain and Lightyear brands will be retired and the combined company will be re-named to Interstellar.

The merger brings Chain's enterprise products and customer base to Stellar's global public ledger, creating an end-toend solution that will enable organizations to issue, exchange, and manage assets on a highly-scalable public network. Chain's cloud ledger service, Sequence, will allow organizations to easily track assets as they

- Adam Ludwin, who is Chain's CEO, will be Interstellar's CEO
- Jed McCaleb, who co-founded the Stellar Development Foundation and Lightyear, will be CTO of Interstellar
- The Stellar Development Foundation, which develops the Stellar protocol and supports the open source community, remains independent
